Q: WHO IS ELIGIBLE FOR THIS BONUS?

A: All Market Partners in the USA, Canada, Mexico, UK, Ireland, Poland, Spain, Lithuania, France, Belgium, Germany, Austria, Australia and New Zealand.

Q: WHAT IS THE POWER OF 2 BONUS?

A: Each calendar month, Market Partners have the exciting opportunity to earn big with unlimited stackable bonuses! Here's how it works:

1. Mid-Month! Earn a £160/€180 Bonus

Sponsor at least 1 qualifying Market Partner (MP) and 4 qualifying VIP Customers by the 16th of the month at 04:59 AM BST and you'll receive a £160/€180 Bonus.

2. Full Month! Earn a £240/€270 Bonus

For every 2 qualifying Market Partners and 8 qualifying VIP Customers you sponsor by the first day of the following month at 04:59 AM BST, you'll receive a £240/€270 Bonus.

This bonus is stackable the more you do, the more you earn!

3. Stack & Max Out – Earn up to £400/€450 (or more!)

Complete both the Mid-Month Incentive and the Full Month bonuses to lock in a total of £400/€450. Plus, the Full Month Bonus is stackable—so every time you sponsor an additional 2 qualifying MPs and 8 qualifying VIPs, you'll earn another £240/€270 bonus. The more you build, the more you earn—all the way through the end of the month!

SEPTEMBER MIX & MAX INCENTIVE 1st–30th September 2026

1. Mid-Month Incentive — Earn a £160/€180 Bonus

Sponsor a total of 5 qualifying new MPs and/or VIP Customers in **ANY** combination by 16th September at 04:59 a.m. BST.

Minimum requirement: At least 1 of the 5 enrolments must be a qualifying MP.

Examples of qualifying combinations include:

2. Full-Month Incentive — Earn a £240/€270 Bonus

Sponsor a total of 10 qualifying new MPs and/or VIP Customers in **ANY** combination by 1st October at 04:59 a.m. BST.

Minimum requirement: At least 2 of the 10 enrolments must be qualifying MPs.

Examples of qualifying combinations include:

Qualifying MPs	Qualifying VIP Customers	Total Enrolments
2 MPs	8 VIPs	10
3 MPs	7 VIPs	10
5 MPs	5 VIPs	10
10 MPs	0 VIPs	10

3. Stack & Max Out — Earn £400/€450 or More!

Complete both the Mid-Month Incentive and one Full-Month Incentive level to earn a total of **£400/€450**. The Full-Month Bonus is stackable. For every 10 qualifying MP and/or VIP enrolments, you'll earn an additional **£240/€270**.

Minimum requirement: At least 2 qualifying MPs for every 10 total enrolments.

Q: WHAT IS CONSIDERED A QUALIFYING MARKET PARTNER?

A: A qualifying MP is an MP who enrolls with a Product Pack or achieves 200 PV by the last day of the calendar month at 11:59 p.m. ET.

Q: WHAT IS CONSIDERED A QUALIFYING VIP?

A: A qualifying VIP is a VIP that has an initial order of £60/€75 or more and has a Flexship scheduled for £60/€75 or more. If in the event there is a promotion that allows a VIP to enrol at a lower dollar amount, they will also count as a qualifying VIP as long as they have a Flexship scheduled for £60/€75 or more.

Q: IF I SPONSOR AT LEAST 1 QUALIFYING MARKET PARTNER AND 4 QUALIFYING VIPS BY THE MID MONTH DEADLINE, AM I GUARANTEED THE £160/€180 BONUS?

A: Yes!

SEPTEMBER MIX & MATCH: You may also earn the £160/€180 Mid-Month Bonus by sponsoring any qualifying combination of 5 total MPs and/or VIPs by the Mid-Month deadline, provided at least 1 of the 5 enrolments is a qualifying MP.

Q: IF I SPONSOR 2 OR MORE QUALIFYING MARKET PARTNERS AND 8 OR MORE QUALIFYING VIPS IN A CALENDAR MONTH, BUT DON'T MEET THE MID-MONTH GOAL BY THE 15TH OF THE MONTH, HOW MUCH WILL I EARN?

A: You'll receive a £240/€270 bonus for meeting the full-month qualification—even if you missed the mid-month bonus.

SEPTEMBER MIX & MATCH: The same applies if you complete any qualifying combination of 10 total MPs and/or VIPS by the Full-Month deadline, provided at least 2 of the 10 enrolments are qualifying MPs.

Q: WHEN WILL THE BONUSES BE PAID?

A: The bonuses will be paid with monthly commissions following the close of each calendar month.

Q: ARE NEW MARKET PARTNERS ENROLLED ELIGIBLE FOR THE POWER OF 2 BONUS?

A: Yes, all Market Partners are eligible for the Power of 2 Bonus. To qualify you must meet the requirements outlined above.

Q: IF I ENROL A MARKET PARTNER OR VIP IN ANOTHER COUNTRY, WILL THEY COUNT AS ONE OF MY REQUIRED MARKET PARTNERS OR VIPS?

A: Yes. Every Market Partner who enrolls with a Product Pack or who achieves 200 PV by the end of the calendar month will count, regardless of their country of enrolment. The same applies to each Qualifying VIP—international enrolments are included.

Q: IS THE PRODUCT PACK RETURNABLE?

A: MONAT is confident that you'll love everything you purchase from us. We offer a 30-day money back satisfaction guarantee (excluding shipping and handling charges) to all customers and Market Partners. After 30 days, MONAT offers a 90% refund of the purchase price (excluding shipping and handling charges) on the return of all unopened and unused product. We will happily refund the purchase price (excluding shipping and handling charges) of returned item(s) to the original form of payment. Any returns after 90 days from when the customer or Market Partner receives their order will not be accepted. Q: IF I ENROL A MARKET PARTNER OR VIP AND THEY REQUEST A REFUND, WILL THEY STILL COUNT AS ONE OF MY REQUIRED MARKET PARTNERS OR VIPS?

A: If an MP or VIP requests a refund and no longer meets the requirements of a qualifying MP or VIP, they will not count towards the Power of 2 Bonus requirements. In the event a bonus is paid, MONAT reserves the right to clawback the paid bonus amount.

Q: WHAT HAPPENS IF I ENROL A VIP IN A COUNTRY WITH A FLEXSHIP REQUIREMENT AND MY VIP CANCELS THEIR FLEXSHIP?

A: If a VIP cancels their Flexship, they will still count toward your Power of 2 qualification requirements. MONAT will continue to monitor Flexship activity to ensure the integrity of the qualifications. As part of this process, Compliance will review accounts of MPs who earn the Power of 2 bonus and have a higher-than-average rate of Flexship cancellations.

Please note that all bonuses are subject to Compliance review and final closing. Any purchases or enrolments not in compliance with MONAT Policies and Procedures will be deemed ineligible. Additionally, any violation of MONAT Policies and Procedures may render a Market Partner ineligible to participate in the programme and may result in compliance action to the Market Partner's account.
