Q: WHEN DOES THIS INCENTIVE OCCUR?

A: This incentive begins on Sunday, 1st February 2026 at 9:00 am GMT and ends on Sunday 1st March 2026 at 4:59 am GMT.

Q: WHO IS ELIGIBLE FOR THIS INCENTIVE?

A: All Market Partners in the USA, Canada, Mexico, UK, Ireland, Poland, Spain, Lithuania, France, Belgium, Germany, Austria, Australia, and New Zealand.

Q: WHAT IS THIS INCENTIVE IN DETAIL?

A: During the month of February 2026, Market Partners have an exciting opportunity to earn a 50% Matching Bonus when they complete the Power of 2 and their personally sponsored Market Partners (new or existing) do the same. Here's how it works:

1. Mid-Month Matching Bonus – Earn £80/€90

Complete the Power of 2 Mid-Month requirement, and when your personally sponsored Market Partners also complete the Mid-Month requirement, you'll earn a £80/€90 matching bonus for each MP who qualifies.

2. Full Month Matching Bonus – Earn £120/€135

Complete the Power of 2 Full Month requirement, and when your personally sponsored Market Partners also complete the Full Month requirement, you'll earn a £120/€135 matching bonus for each MP who qualifies.

3. Stack & Max Out Your Earnings

For EVERY personally sponsored Market Partner who completes both the Mid-Month and Full Month Power of 2, you can earn up to £200/€225 in total matching bonuses.

Q: IF MY PERSONALLY SPONSORED MARKET PARTNER COMPLETES THE POWER OF 2 MID-MONTH REQUIREMENTS AND I DO NOT, WILL I RECEIVE THE 50% MATCHING BONUS?

A: No. To qualify for the Mid-Month 50% Matching Bonus, both you and your personally sponsored Market Partner must complete the Power of 2 Mid-Month requirements.

Q: IF MY PERSONALLY SPONSORED MARKET PARTNER COMPLETES THE POWER OF 2 FULL MONTH REQUIREMENTS AND I DO NOT, WILL I RECEIVE THE 50% MATCHING BONUS?

A: No. To qualify for the Full Month 50% Matching Bonus, both you and your personally sponsored Market Partner must complete the Power of 2 Full Month requirements.

Q: DO I RECEIVE THE 50% MATCHING BONUS FOR EVERY 2+8 MY PERSONALLY SPONSORED MARKET PARTNER COMPLETES?

A: No. The 50% Matching Bonus for the Power of 2 Full Month may only be earned one time per personally sponsored Market Partner, regardless of how many times they complete a 2+8.

Q: WHEN WILL THE 50% MATCHING BONUSES BE PAID?

A: The bonuses will be paid with February monthly commissions in March.

Q: IF I ENROL AS A NEW MARKET PARTNER IN FEBRUARY 2026, AM I ELIGIBLE FOR THIS INCENTIVE?

A: Yes, all Market Partners are eligible for this incentive. To qualify you must meet the requirements outlined above.

Q: WHAT IF I DIDN'T GET THE EMAIL ABOUT THIS INCENTIVE?
